"They make life a more comfortable and safer place for us all"


Credit again must be given to our state leaders for their management of our communities as it has been done with great consistency, empathy and understanding while maintaining concern for other jurisdictions.

Our residual funds continue to work under investment advised by William Buck to provide continued support for our volunteers as we are aware that the need to support them does not stop because the fires stopped burning or accidents occurring.

I also wish to pay tribute to the Foundation Board members, Karen Ross, David Stobbe, Sue Renner, Andrew Lawson, Mark Sutton, Rob Nelson, Anne Lucas & Mark Jones who all contribute their time, skill and passion as absolute volunteers because they too want to improve the wellbeing of all impacted as a result of caring for our community.

A YEAR IN REVIEW

Mourning the loss of a very special CFS volunteer

January 2021 saw us lose a very special CFS volunteer, Louise Hincks who was killed fighting a bushfire near Coles in the South East in January this year.

Louise was a committed CFS volunteer for 28 years and a beloved member of the Happy Valley CFS brigade where her daughters are also cadets. She was formerly a staff member of SAFECOM where she delivered mental health programs across the state to fellow CFS volunteers. Her loss has been felt across many areas of the Country Fire Service family. In the same incident, another volunteer was seriously injured but thankfully is recovering.





The CFS Foundation proudly offered immediate financial assistance to both families which gave them some peace of mind following the tragic accident.

Louise's commitment to the Country Fire Service has been acknowledged at the South Australia Volunteer Fire Fighters Museum memorial and in Canberra at the National Emergency Services Memorial. A memorial garden is currently being developed at the Happy Valley CFS brigade in honour of Louise.

Move into Emergency Services Headquarters

January 2022 saw the CFS Foundation move into offices on the ground floor of the new South Australian Emergency Services Headquarters, located at 37 Richmond Road, Keswick. The purpose-built facility houses the headquarters for the Country Fire Service (CFS), Metropolitan Fire Service (MFS), State Emergency Service (SES), and the South Australian Fire and Emergency Services Commission (SAFECOM). We would like to recognise the South Australian Government for giving us this office space at no charge. Being in the same building as the CFS certainly makes building relationships and communicating with CFS staff and management much easier.





Celebrating 20 years of supporting CFS volunteers

In October 2020, the CFS Foundation held a lunch at The Sanctuary, Adelaide Zoo to celebrate 20 years of supporting CFS volunteers. This lunch was also the ideal opportunity to thank the sponsors who continue to support us plus celebrate our recent achievements. Brenton Ragless, a CFS volunteer and Ambassador of the CFS Foundation was the MC and he introduced some wonderful speakers including Shane Leahy, garlic farmer and Parndana CFS brigade lieutenant who relayed his stories of the devastating bushfires of the 2020 summer. Comfort Koalas

We are happy to have distributed over 250 'Comfort Koalas' to CFS brigades at no charge over the last few years. These koalas are kept in CFS trucks and are given to children involved in vehicle accidents or other incidents. A Comfort Koala can be a way of providing ease for a distressed child and can shift the attention away from the incident and towards something soft, gentle and soothing.



Expanding our Constitution

This financial year also saw the CFS Foundation Board approve the expansion of the CFS Foundation Constitution which enabled us to provide a wider range of services to CFS volunteers and Brigades including being able to purchase vital equipment for Brigades and fund other initiatives to assist our CFS volunteers and Brigades.

Thanks to our sponsor Police Credit Union, 20 brigades each year receive a Nespresso Coffee machine.
